Thank you for your donation to Ditto! To claim this as a charitable deduction, the IRS requires you to itemize and value your items. It's easy to get started - just follow this two-step process:

1. Refer to the following Valuation Guide for Ditto Donors when assigning a value to your donation. This guide lists the estimated tax-deductible values of items we most commonly sell at Ditto. The list is for tax itemization purposes only and assumes donated items are in good used condition, or better.
2. Itemize and record these values on your Ditto Donation Receipt. We offer this receipt each time you donate as confirmation of your contribution. Ensure it is dated and signed by a Ditto representative. Please note, Ditto does not retain a copy of this receipt.
